Dear Artist

New Kent Art Gallery & Studio opened its doors in the very heart of beautiful Broadstairs town in 2016, just yards from the seafront and harbour.

The intimate, fine art gallery space focusses on local artists, showcasing stunning work in traditional and contemporary styles, together with resident artists in a working studio. Paintings, sculptures, crafts, ceramics, gifts and one-off pieces will be available to admire and buy in the gallery or online from our website.

In response to a lack of gallery space, two local artists, RA exhibitor Brian Hodgson and Karen Hiscock-Lawrence, set up a studio and affordable gallery space for artists based in Kent to hire and showcase their work, as well as holding organised 'open shows' throughout the year. Changing exhibitions every fortnight will provide residents and visitors to Broadstairs an exciting art experience, as well as a hub for artists and makers to pop in for a chat.

Artists can book the gallery for a solo exhibition or as a collaborative of ideally up to 4 artists. The hanging space is set out as a long, galley style room (approx. 7mx2.5m), with 3 large window display areas and some display case/plinth space. We are flexible as to the layout and will assist the artists in hanging their work to create the best exhibition possible whilst maintaining the 'look and feel' of New Kent Art Gallery as a whole.

If you would like to book a slot for this year, please fill in the booking form. Availability is on a first come, first serve basis and based upon a fortnightly calendar there will be a maximum of 26 slots.

Gallery Booking Enquiry

Bookings for solo or group exhibitions are for a 1 or 2 week period (single weeks by agreement). There will be availability throughout the year with a high and low season several 'Open Exhibitions', pre-scheduled selected by the gallery.

Booking is fully inclusive of hanging, full-time staffing of the gallery, use of facilities for Private View and exhibition, advertising on our website, social media and local press wherever possible and inclusion on our online gallery and shop for at least the term of the exhibition.

Exhibition hanging and changeover takes place on Mondays when the gallery is officially closed, although drop off and collection of work will preferably be at the weekend by arrangement.

Fees & Deposits

Low Season (1st Jan-1st March)	£315 per fortnight (£185 per week)
High Season (1st March – 31st Dec)	£350 per fortnight (£195 per week)

£100 non-refundable deposit is payable upon booking and completion of the booking form. Balance is payable at the commencement of Exhibition.

Works sold during the exhibition period will be liable to a 25% commission charge. This rate applies to all work sold in the gallery and online via our website.

Cancellation Policy

If you should cancel your booking, the following terms apply if a replacement artist booking cannot be arranged in your place.

More than 2 months prior to the booking date – 50% of fee payable More than 1 month prior to the booking date – 70% of fee payable Less than 1 week prior to the booking date – 90% of fee payable

General Facilities

The gallery will be prepared by us and cleaned for the duration of the exhibition and staffed during normal working hours. Exhibiting artists are welcome to be present during their exhibition as 'artist in residence' and use the gallery to work on small pieces of work or simply meet and greet visitors to the gallery. Whilst there, they may also use the kitchen area and bathroom.

Terms

- a) Exhibitors must deliver work to the New Kent Art Gallery before the exhibition by arrangement with the curators (on either sat/sun or mon)
- b) Exhibitors can assist with hanging, but the gallery curators will have overall responsibility and are happy to hang for the artists.
- c) Exhibitors should provide a list of works, ideally on a spreadsheet or word document via email, one week before the exhibition, to enable production of labels and literature associated with the show.
- d) Exhibitors should also provide a brief biography, statement or information sheet about their work for advertising purposes. (they may also bring business cards and flyers to their show/preview)
- e) Paintings should be suitably framed and have D-rings and wire/string on the rear suitable for hanging. A small number of standing frames may be displayed.
- f) Drawings and unframed work can be displayed in our browser and greetings cards may also be displayed.
- g) All work sold including cards will be liable to a 25% commission charge.
- h) Private Views may be arranged by agreement for the first Friday or Saturday of the fortnightly booking, during the day or on the Weds evening between 6.30-8.30pm in the evening.
- i) The gallery can provide some glassware and kitchen facilities, but Exhibitors must provide their own refreshments for their guests during preview evenings.
- j) Whilst New Kent Art has building, contents and public liability insurance we recommend artists insure their own work whilst it is in situ at New Kent Art Gallery.
